### IN HONOR OF ALL OUR VETERANS!

Did you know, "The Great War," or WWI, officially ended when the Treaty of Versailles was signed on June 28, 1919? However, fighting ceased 7 months earlier when an armistice between the Allied nations & Germany went into effect, the 11th hour of the 11th day of the 11th month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars." An Act approved May 13, 1938, made the 11th of November in each year a legal holiday—a day to

be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice Day was primarily a day set aside to honor veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after



May God Bless America!

American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American veterans of all wars.

Fellow home owners, I would like to thank all of you for making our neighborhood such a great place to live. Our common areas are one of the great advantages of our community. As a reminder, the following rules should be followed when using the facilities:

- When a community member reserves the club house, they must be present during the event and ensure the facility is cleaned up and locked when it's complete.
- 2. The ice machine is another wonderful perk within our community and a few of the board member's have started bagging additional ice and placing it in the freezer so more of our neighbors can enjoy it. If you are getting ice and there is some left over in the machine, please grab a bag from under the sink and bag up as much ice as you can and place it in the freezer. If we all take part in this process, we will have plenty of ice when community members need it because nothing is worse than finding

- an empty ice machine when you need it the most.
- 3. The boat ramp is for community member use only. The only exception is when a community member is present with their guest and the guest's vehicle has a properly displayed pass in the window. If you need additional passes, please contact any of your board member's prior to your guest arriving.

4. Please help us keep a watchful eye on the clubhouse. Just recently, we had some vandalism at the clubhouse when multiple beer bottles were shattered on the pavement under the clubhouse and

at the boat ramp. It appeared that someone had first drank a few under the clubhouse before shattering the remaining full bottles around the area.

- Because of this low light area, your board members are working diligently to try and get the new security light operational in hopes that the added light on the clubhouse and dock area will deter after-hours use at the clubhouse. I would also like to remind everyone that we as a community are responsible for helping to keep our community area clean. Calling the Sgt-at-Arms to report discrepancies is the appropriate process so we have a record to share with the authorities but it is not the board members responsibility to clean it up; we need to share in those duties as a community.
- Last but not least, please lock the clubhouse when you leave. This will ensure our facilities are secure from unwanted guests.

If we all share in these basic rules, we will be able to enjoy our facilities for years to come.
